### **COVID 19 and HIGH HOLY DAYS SERVICES**

Due to COVID-19 restrictions, our services (Erev Rosh Hashanah, Sept. 6; Rosh Hashanah, Sept 7; Erev Yom Kippur, Sept. 15; and Yom Kippur, Sept. 16) are each restricted to a **maximum of 75 attendees**.

Therefore, **beginning on August 9<sup>th</sup>**, we are asking **all Full and Associate Members to reserve a seat(s) for each of the four services by sending an email by August 31** to [km@kolotmayimreformtemple.com](mailto:km@kolotmayimreformtemple.com) and advise us which services you are planning to attend.

**Beginning September 1**, we will accept reservations from **Friends of Kolot Mayim and in town visitors** at the rate of \$75 per service (or \$200 for all four services).

Non-members who wish to attend services via Zoom may do so through a donation on the day.

Please **do not** forward any monies until you receive confirmation of your reservation.

Please note that attendees will need to check-in at the time of the service in order that we may track attendees.

**NOTE:** While we encourage everyone to have received their two vaccinations before August 31, we will not require attendees to identify this.

## A BIT OF HISTORY AND A REQUEST

Thank you for continuing as a member of our congregation, Kolot Mayim Reform Temple. As you know our Congregation is a strong, vibrant group of people with the values of the Reform Movement as our inspiration. Also, Kolot Mayim has become the spiritual home to families and individuals that previously struggled to find a place where they belonged. There are no barriers for anyone regardless of their level of Jewish knowledge, observance, or practice.

**Why do our members want to give to support the congregation?** Because Kolot Mayim Reform Congregation does all kinds of wonderful things for its members. We take care of each other in times of need and in times of celebration – we are a Jewish Reform community that has come, and stays, together based very simply and clearly on Jewish values. From the first week we found ourselves sheltering in place, we have been sharing the message that while our building is closed, our synagogue is very much open and thriving. **Our increasing membership during the pandemic is a testament to our community.**

We have new and innovative ways to connect and “be together” virtually for worship, education, pastoral and community gatherings. And while we have certainly missed being together in-person, we have created new holy spaces where we have been able to pray, celebrate and mourn with one another. While the meeting place may be “virtual”, the care, passion, compassion, prayer, and friendship are all as real as ever. **As we transition into face-to-face services and activities, we will endeavour to retain the virtual option as many of our members have grown to appreciate it.**

The actual cost of keeping the doors open on a per person basis is not covered by our individual annual commitments. Of course, if someone is unable to pay the full annual commitment, we never refuse them as members. We operate with a shortfall every year. Our gross revenue from membership commitments is about \$40,000. It costs about \$50,000 just to “keep the door open”, so we hope to find as many people as possible who can pay the full annual commitment of \$700 per person. If you can pay more, that is even better since you support those who cannot. **This year especially we will have additional technology costs in order to have hybrid services, meaning Zooming at the same time as face-to-face services.**

Thanks to a few generous members and former members we have been able to sustain ourselves financially as our annual membership commitments do not cover our costs of operation. Therefore, every year we ask those of our members who can, to make a Voluntary Fair Share donation over and above their annual dues and every year some folks are able to do so.
